6) **UTC Update**

Sean Mayo briefed the Committee on the following:

Agency Level:

- The UTC building remains closed to the public.
- Nearly all Staff telework and Open Meetings are held virtually.

Program Level:

- Since the last meeting, Staff has completed 10 scheduled inspections, 97 unannounced inspections, and 50 facility inspections.
- Responded to 31 incident calls.
- The UTC has provided technical assistance in a new renewable natural gas (RNG) construction project.

PHMSA Level:

- PHMSA is engaged in assisting Colonial Pipeline in the recovery of their cyber attack.
- PHMSA has opportunities for pipeline operators to participate in a Validated Architecture Design Review program (VADR). VADR is the Transportation Security Administration's voluntary project where an operator can volunteer to have Homeland Security and TSA conduct an assessment to proactively identify and mitigate cyber vulnerabilities on their systems.
- PHMSA is focusing on climate change and transportation as an engine for equity.

- Sean Mayo will reach out to TSA contacts requesting a presentation on cybersecurity issues.
